Rochdale Township Area Forums Code of Conduct

Conduct at meetings

- Attempt as far as possible to stick to the agenda and assist each other to reach effective conclusions
- Operate within the constitution where applicable
- Aggression, violence, threats, harassment, intimidation and other disruptive behaviour in the forum will not be tolerated
- The term 'members' applies to all those present at the meeting

Confidentiality

- Members will refrain from mentioning specific individual cases which may cause embarrassment or identification of an individual
- Any information or item shared that is of a confidential nature will not be disclosed to anyone else apart from members of the Forum in order to allow the business of the meeting to proceed.

Dignity at meetings

- All those who attend Forum meetings have the right to be treated with dignity and respect regardless of their race, colour, ethnic or national origin, nationality, gender, marital status, age, sexuality, religion or any other matter which causes people to be discriminated against
- The meeting will do all that is in its power to oppose all forms of harassment and bullying

Individual Members

- Should disclose any personal interest that they consider may affect or influence their approach to the matter being discussed
- Must show respect in all their dealings by observing reasonable standards and courtesy, and by not seeking to take unfair advantage by virtue of their position

Political Affiliation

- Even though individual members may be affiliated to/or be members of a political party, they may not represent a political party in their role as individual members of this Forum
- Elected Members attending meetings outside the ward they represent may be allowed to speak, at the discretion of the Chair.

Breach of Code of Conduct

- If anyone attending the Forum meeting does not abide by the code of conduct, the Chair will have the discretion to decide on an appropriate course of action. The Chair may either issue a warning, ask the person to withdraw from a particular agenda item or exclude that person from the meeting.
- Where a person is asked to leave a meeting, the Chair will have the discretion to decide whether or not that person is welcome to attend future meetings.
- The Chair at his/her discretion, may close the meeting if he/she deems it necessary

WELCOME, INTRODUCTIONS, APOLOGIES AND CODE OF CONDUCT 102

The Chair welcomed everyone to the meeting and requested that the Forum respect the Code of Conduct for the duration of the meeting.

Apologies had been received from J. Molyneux, B. Penty, C. Dodgson, M. Rashid, Jason Addy, N. Morrell, A. Meek and T. LeMonnier.

LOCALITY PLAN 103

Phil Burton (Engagement Lead NHS Heywood, Middleton and Rochdale Clinical Commissioning Group) attended the meeting for this item.

The Forum was informed that the Health and Social Care Budget was devolved to Greater Manchester in April 2016. As a result The Greater Manchester Health and Social Care Partnership was set up to oversee the devolution of Health and Social Care. To support this process a Transformation Fund of £450 million was provided until 2020/21 to transform the health and social care system and make it sustainable.

In order to achieve this vision a number of significant challenges have to be overcome:

- The health and social care system can be complex to navigate which can lead to fragmented care gaps and duplication.
- A complex system means that it is difficult for both service users and professionals to know where in the system needs can be best met.
- A complex system wastes time and resources for all parties.

From a Rochdale perspective the above challenges are further compounded because:

- The health of many in the borough is worse than the national average. Rates of smoking, obesity and many long term conditions are high.

- Behaviour change is needed to prevent ill health and help local people get healthier.

Therefore Rochdale's approach will need to target resources in communities where there is the greatest need, prevent the start of unhealthy habits and long term conditions and reduce the impact of those conditions. Prevention activity across the borough will need to increase.

From a Greater Manchester viewpoint the five transformational themes going forward are:

- Radical update in population health prevention.
- Transforming community based care and support.
- Standardising acute hospital care
- Standardising clinical support and back office services.
- Enabling better care.

Rochdale's locality plan themes will include:

- Prevention and access. – changing lifestyles / easy access to services.
- Neighbourhood and primary care – care as near to home as possible
- In hospital care – more patient involvement
- Carefully supporting children, young people and families
- No health without mental health.

In simplistic terms it is hoped that the above will have a significant impact on health and social care across the borough and Greater Manchester.

Residents raised the following issues.

- Timely GP appointments are difficult to arrange.

This was accepted and understood. However steps have been taken to try and reduce this occurrence with GP's surgery's opening longer hours. Attempts are also being made to recruit more GP's.

- Why are delays happening in the health care system

Numerous reasons – people living longer, people use service for wrong reason and there is still wastage in the system. However there are intermediate tiers in place at the four locality hubs which is easing pressure on Accident and Emergency Departments (A&E) and GP's are also present at A&E.

- Ashworth Surgery is good at getting appointments.

It was accepted that some surgeries are good at this and others need to improve. Work needs to be done to ensure consistency across practices.

- Receptionists sometimes aggravate the situation

This was understood, however receptionists are gatekeepers to the service and will have been specifically trained in questioning.

- What role does Healthwatch play in this transformation plan

Healthwatch Rochdale is the local independent champion for people using health and social care services in the Rochdale borough. The primary purpose of Healthwatch Rochdale is to listen to what people like about services and what could be improved. This information is shared with those who have the power to make change happen locally.

- How will the Ambulance Service be affected transformation.

GREATER MANCHESTER POLICE INCLUDING PACT MEETING

104

PC Phil Jones and PCSO Dan Smout attended the meeting for this item.

The Forum was informed of the following issues:

1. Operation Dragster on Sunday 28th January seized two motor bikes and two Land Rovers and numerous warnings were given. Although much negative feedback had been received in relation to this operation on social media, GMP commented that a great deal of this feedback was by the same people who appear to have an interest in off-road biking.

PC Jones informed the Forum that a repeat operation would occur in the future.

The Forum was very supportive of this exercise and welcomed the idea of a repeat exercise.

2. Meanwood School had been visited on two occasions at morning times to deter inconsiderate / dangerous parking / driving. More patrols will be undertaken in the future.
3. Safety / security concerns have been highlighted about Caldershaw Mill. This issue is ongoing.

4. Two successful surgeries have been held at Spotland Library. The next surgery is at Spotland Community Centre on Tuesday 13th March 2018, commencing 2.30pm.
5. Burglary still remains a problem across the borough. Forum members were encouraged to take simple precautions to help deter / prevent incidents of this nature.

A persistent offender is currently in custody, however he is due out in the next two weeks.

6. Mosquito devices have been installed at Denehurst Park and Ravendale Court in response to complaints about anti-social behaviour. Consideration is currently being given to the fitting of CCTV on Phoenix Street.
7. Police patrols have been increased on Spotland Road and Falinge Park.

The Chair thanked GMP for the work they undertake in the Ward. This was endorsed by the Forum.

COUNCILLOR UPDATES/NEWS

The Chair informed the Forum that this would be Councillor Surinder Biant's final Forum in his role as Ward Councillor. The Chair thanked Councillor Biant for his services to the Ward over many years and the money raised for local charities during his role as Mayor. This was endorsed by the Forum.

The following updates were provided by the Ward Councillors.

Councillor Cocks informed the Forum of the following:

- Involved in numerous in-bloom projects
- Recently been appointed Chair of the Health, Schools and Care Overview and Scrutiny Committee. The Ambulance Service have been invited to the next meeting of this Committee.
- A new manager is in place at Spotland Library.
- A meeting has been arranged with First Bus to discuss bus services in the Ward.
- Involved in proposals to make Rochdale an age friendly borough.
- Involved in work around private rented housing.
- There was nothing to report on the TBA site.

Councillor Cecile Biant:

- Commented on the loss of the bus service at Catley Lane Head.
- Advised the Forum that work on Ashworth Street and Cutgate Road may commence in the next 4 weeks.
- Advised the Forum that the New House Bonus would cover the cost of the loss of Section 106 contributions from the Mellor Street development.

Some residents expressed their dissatisfaction with the way in which the Council had dealt with the Section 106 variation on the Mellor Street development.

The Forum was also advised, that due to changes in the way Section 106 contributions are managed, ideas for the future funding of projects from Section 106 contributions would need to be identified at the planning application stage.

It was also commented that Councillors should also arrange a meeting with Rosso Bus Services in addition to First Bus to discuss local provision.

OPEN FORUM - AN OPPORTUNITY FOR LOCAL RESIDENTS TO COMMENT ON ISSUES IN THE WARD

108

The Forum was informed that:

The next Friends of Denehurst Park meeting will be held on Thursday 22nd February 2018 commencing 6.30pm at Spotland Library.

The Big Clean Event will happen on Saturday 3rd March 2018. Projects are hoping to be planned in the Ward.

A discussion took place about how to deal with the school fencing that was removed from Meanwood School many months ago and is currently stored at Environmental Management Depot at Green Lane. The Chair informed the Forum that considerable time and effort had been put in to identifying an appropriate site for the fencing without success. A major issue with the fencing is that it is spiked and the Council's Health and Safety Team would not support the re-siting of the fencing in its present condition. The Forum was also reminded that a resident had planned to restore one section of the fencing, however it was unsure if this had happened. After debate the general view of the Forum was that the fencing should be scrapped. Because of the heritage value of the fencing The Township and Engagement Officer agreed to speak to the Council's Conservation Officer to understand what would be the best way to dispose of the fencing.

At a previous meeting of the Forum a resident asked if the Council owned the footpath opposite to Preston Street as it was in need of improving. The resident was informed that the Council did not own the land, however attempts would be made to identify the landowner.

A resident commented that the footpath on Ings Lane was in poor condition and the area around the bins on Ings Lane was in need of attention.

A resident also asked if the footpath close to Passmonds Garage was a public right of way. It was suggested that if it was the Community Payback Team could be asked to improve the area.

The Township and Engagement Officer agreed to investigate these issues further.

The Forum was informed that Rooley Moor Neighbourhood Forum had recently been awarded just less than £10k from the Heritage Lottery Fund. Some of this money would be used to support additional signage in the area together with researching the history of the area. A resident asked if the future of open spaces in the Ward, for example Falinge Park, Ings Lane and Denehurst Park would continue to be accessible to the public. What safeguards are in place to protect this land's existing status.

The Township and Engagement Officer would investigate this further.
