Agenda Item 2

Rochdale Township Area Forums Code of Conduct

It is established by and for the Rochdale Township Area Forums that the following code of conduct will govern the behaviour of their members. The code of conduct will be enforced by the Chair of this meeting.

Conduct at meetings

Members will at all times observe accepted practice while taking part in discussions to:

- Be courteous to each other and support and assist other members in finding the best possible solution to problems being discussed
- Allow each other the opportunity to speak and comment
- Attempt as far as possible to stick to the agenda and assist each other to reach effective conclusions
- Operate within the constitution where applicable
- Aggression, violence, threats, harassment, intimidation and other disruptive behaviour in the forum will not be tolerated
- The term 'members' applies to all those present at the meeting

Confidentiality

- Members will refrain from mentioning specific individual cases which may cause embarrassment or identification of an individual
- Any information or item shared that is of a confidential nature will not be disclosed to anyone else apart from members of the Forum in order to allow the business of the meeting to proceed.

Dignity at meetings

- All those who attend Forum meetings have the right to be treated with dignity and respect regardless of their race, colour, ethnic or national origin, nationality, gender, marital status, age, sexuality, religion or any other matter which causes people to be discriminated against
- The meeting will do all that is in its power to oppose all forms of harassment and bullying

Individual Members

- Should disclose any personal interest that they consider may affect or influence their approach to the matter being discussed
- Must show respect in all their dealings by observing reasonable standards and courtesy, and by not seeking to take unfair advantage by virtue of their position

Political Affiliation

- Even though individual members may be affiliated to/or be members of a political party, they may not represent a political party in their role as individual members of this Forum
- Elected Members attending meetings outside the ward they represent may be allowed to speak, at the discretion of the Chair.

Breach of Code of Conduct

- If anyone attending the Forum meeting does not abide by the code of conduct, the Chair will have the discretion to decide on an appropriate course of action. The Chair may either issue a warning, ask the person to withdraw from a particular agenda item or exclude that person from the meeting.
- Where a person is asked to leave a meeting, the Chair will have the discretion to decide whether or not that person is welcome to attend future meetings.
- The Chair at his/her discretion, may close the meeting if he/she deems it necessary

1. WELCOME, INTRODUCTIONS AND APOLOGIES

Introductions were made and all were welcomed to the meeting.

2. CODE OF CONDUCT

The Chair referred to the code of conduct and asked all to abide by the code for the duration of the meeting.

3. MINUTES OF THE LAST MEETING AND MATTERS ARISING

The minutes of the previous meeting on Thursday 31 May 2018 were agreed and the following updates were given.

Fly tipping

Public Realm Inspector, Diane Lodwig, has continued to remove all reported fly tipping from around the Holborn Street area and to address the issue of bins being left permanently on the street.

Cotton Lane water problem

Cotton Lane has been cleaned up and further dumped rubbish removed. The Council's Rights of Way Officer is assessing the location for resurfacing to prevent it from going under water when it rains.

Roch Valley Way speed survey

The Roch Valley Way speed survey has been concluded. The results were made available to all with a breakdown of volume and speed of vehicles by the hour at each of the two locations. Highways completed a review of the survey results with conclusions and options which was also made available to all.

The survey took place between 8 and 15 March 2018. The average speed of the 91,201 vehicles recorded in the week at location number one, outside 59 Roch Valley Way, in both directions was 25.2mph, however out of those, 1,722 were recorded travelling over 35mph. The average speed of the 82,990 vehicles recorded at location number two, Lighting Column Number 25, North West of Roch Mills Crescent, in both directions was 32mph, however out of those a massive 25,142 vehicles

were recorded travelling in excess of 35mph. As Roch Valley Way is part of the Strategic Network, physical measures such as speed humps cannot be considered but to add to the existing calming features, the interactive sign will be repaired and mature obstructive trees trimmed back. Provision of a central traffic island at the 30 to 40 speed limit to create a gateway and pinch point and the lining along the length of the 30mph limit be renewed. Some of this work will require funding to be approved. Highways will be asked to consider installing the central traffic island referred to, on safety grounds given the results, to create a gateway and pinch point to slow traffic down.

Blocked drains

The blocked drains on old Manchester Road in Sudden Village were all investigated and cleared, except the one outside the bookmakers for which a further request will be made to have it cleared.

Manchester Road carriageway condition

Highways inspected the reported sinking carriageway on the main Manchester Road at Sudden on the Rochdale bound carriageway just past the bus stop and pedestrian crossing and report that no work is necessary.

Sudden Village entrance road markings and Bramley Road/Greenvale junction Give Way

The worn away road markings at both the entrance into and exit out of Sudden Village were reported with a request to reline them as were the junction markings of Bramley Road and Greenvale.

Recycling bin

The blue recycling bin that had been requested on numerous occasions was delivered to the resident in question the following day.

4. POLICE AND COMMUNITIES TOGETHER

PC Michelle Farmer is the Bamford Neighbourhood Policing Team Officer and she is responsible for the three large geographical areas of Bamford, Castleton and Norden. PCSO Colin Taylor has moved on and he has been replaced by PCSO Sana Haider who has already been very active around the area including reassurance visits to victims of burglary and particularly in one nasty case.

The recent crime statistics for the area were provided. In June 2018 there were two burglaries, one of which was commercial, one theft of a motor vehicle and four thefts from motor vehicles. In July 2018 there were five burglaries, no thefts of motor vehicles and five thefts from motor vehicles and to date this month, one burglary and no vehicle crime at all. Access or attempted access, in most of the burglaries, was by smashing or forcing rear patio doors. Two habitual burglars were arrested as a result of the community reporting them acting suspiciously and they have been remanded in custody with further enquiries ongoing. The offenders are from different areas including Salford. All were urged to report anything they consider suspicious.

Inspector MacGregor has confirmed GMP is no longer holding face to face PACT meetings. PACT meetings will be run online and the next meeting will take place between 7pm to 8pm on Tuesday 28 August 2018 and information about the meeting will be advertised. Burglary and vehicle crime remain the PACT Priorities.

Work is ongoing to permanently secure fencing leading on to Roch Valley as the damaged gap is being used by off road vehicles to access the Valley.

PC Farmer has organised a Safe Plate initiative between 3pm and 5pm on Thursday 30 August 2018 at Bamford Precinct which will be advertised. All are welcome to attend.

One resident raised questions over criminality, with some specifics only the Police can answer, and also questioned the Graded Response system and speeding along Bury Road. He volunteered to participate in the upcoming Community Speed Watch initiative PC Farmer is organising in

conjunction with Councillor Sullivan. Homewatch was discussed. PC Farmer will be asked to contact the resident direct.

5. OPEN FORUM

Manchester Road and Law Street junction parking restrictions

Concerns expressed about the parking restrictions at the junction of Manchester Road and Law Street being persistently contravened throughout the day with vehicles obstructing sight lines exiting the junction and making it dangerous. Parking Services will be requested to conduct enforcement visits.

Manchester Road planters

Residents welcomed the new planters that have been installed on Manchester Road to enhance the area.
